

Waste lagoons: (i.e., poultry, swine and dairy operations; food processing plants) Initial: Apply 2 gallons per surface acre of lagoon. Maintenance: Treat daily with one gallon per surface acre. Automated Application Systems are available through CXI. (972) 471-7775

**Compost Starter:** (stacked animal waste, green waste, food waste and other compost material) Apply 8 to 16 ounces of Waste Away per ton. Mix with water to achieve adequate moisture range of 45-60%. Apply early in the composting process.

For Field Application: Apply directly to crop or manure residue at a rate of 1 to 2 quarts per acre per 100 gallons of water. Apply as soon after harvest as possible.

## For Best Results:

- Ensure tank is free of residue, if using chlorinated water, let tank sit for 24 hrs. (with lid removed) before mixing.
- Do not apply when a crop is severely stressed.
- May be mixed with herbicides.
- Clean sprayer and nozzles thoroughly with water or soap (do not use anti-bacterial) mixture.

Note: Storage temp (50 -90 F). Mix with water. Due to the wide variety of uses and variations in severity of areas to be treated, specific application rates and procedures are best determined on a case by case basis. For assistance, please call CXI, LLC, (972) 471-7775.
